Log Cabin Republicans filed a federal lawsuit against the Don't Ask, Don't Tell (DADT) government policy, which went to trial in 2010. The presiding judge ruled in favor of LCR in September, finding the policy unconstitutional, though the decision was vacated a year later after DADT was repealed in December 2010. Log construction was the most common building technique in large regions of Sweden, Finland, Norway, the Baltic states, and Russia, where straight and tall coniferous trees, such as pine and spruce, are readily available. It was also widely used for vernacular buildings in Eastern Central Europe, the Alps, the Balkans and parts of Asia, where similar climatic conditions prevail. In warmer and more westerly regions of Europe, where deciduous trees predominate, timber framing was favoured instead.

LCR initially filed the suit, a facial challenge to the statute, in 2004. A bench trial began on July 13,

2010, before Judge Virginia A. Phillips of the United States District Court for the Central District of California. The Justice Department had unsuccessfully sought to have the suit dismissed, arguing that as long as Congress had a rational basis for passing DADT in 1993, then it is constitutional. The Justice Department also asserted at trial that LCR did not have standing to challenge the law. LCR argued that DADT violates constitutional guarantees of due process and free speech. 0c46954535
