his arrest in January 1993, Casso became one of the highest-ranking members of the Italian-American Mafia to turn informant. After taking a plea bargain in March 1994, he was placed in the witness protection program. In October 1997, Casso was dropped from the program after several infractions, including bribing prison guards to smuggle contraband, giving out false statements during court trials, association with known felons and assaulting inmates. Later that year, a federal judge sentenced him to 455 years in prison for racketeering, extortion and murder. a792804929
